Please be advised: Though we will make every effort to assign the committees as requested, the Lodge reserves the right to make committee assignments based on such things as Delegation strength and time constraints.

- Penelope of the Year**
Duties: The Committee will select the District Penelope of the Year by following the Point System. Remember, Chapters who have a candidate do not serve on the Committee and each Chapter shall have only one representative on the Committee.
- Chapter of the Year**
Duties: The Committee will select the outstanding Chapter of the District following the Point System provided.
- Resolution and Legislation**
Duties: The Committee works on changes of the DOP Constitution, Ritual, District #3 Bylaws or Guidelines to District #3 Convention. Remember, successful resolutions pertaining to National will be forwarded to the Supreme Convention for consideration.
- Grievance**
Duties: The Committee will discuss and present any grievances to the Chapter, the District or National level and suggest possible resolutions.
- Growth and Expansion**
Duties: The Committee will consider and propose ways to enlarge and retain our Membership.
- Budget and Finance**
Duties: The Committee will work on the District budget for the upcoming year. In accordance with our District #3 Bylaws, a proposed budget will be presented by the District Treasurer based on the previous year's income and expenses. The Committee should also consider possible income sources for the District, giving specific plans on project funding.
- District Scholarship Project**
Duties: The Committee will review the District Scholarship plans for the upcoming year. n.
